- * includes pre-1965 parks; golf courses; trails; and parks in natural undeveloped state. At P&R Cmsn mtg, Director Jon Cicirelli confirmed:
- * includes entirety of each park; incl. full ROW of trails; incl. Gardner Com'nty Cntr at Bierbrach ("it's adjacent"): >> it'd be nice to have that "in writing"!
- * GSI (Green Stormwater Intrastructure) and Flood Mitigation: Dir. is adamant that parkland won't be lost, and that others would pay for any maintenance or damage. (But what about the next Director when Jon eventually leaves or retires?)
- * re: unbuilt parks: not protected by Charter language. Dir. does not see major danger: devel'pr would have to pay City for full price of land *and* redo a CEQA: \$\$\$. But: often there's no other available land to buy, and State has streamlined CEQA to the point that's it'd just be a minor inconvenience rather than a major deterrence. >> Change City Charter to protect undev'lpd land? Would require vote of public: iffy! but City has vote for amending Charter every so often: get "in line" & be ready? >> Action: send "clarifying" follow-up letter to Mayor & Council? Motion by Kathy, 2nd by Ed, to write letter on behalf of D6NLG, summarizing above points.
- Feb. 7: Citywide Sustainable Park Maintenance
 Also: Children & Youth Services; follow-on to Mayor's Gang Prevention Task Force;
 "cradle to career"
- All Districts Leadership Group Larry Ames / Bill Rankin Sat Feb 10th, 10AM
 - SJADLG is drafting a letter to Mayor re: suggestions for city budget
 - * Community Budget input used to be done by SJ's N'hds Cmsn, but that's been suspended, and so SJADLG is trying to fill in for them.)
 - * First step in months-long process: suggest ideas for Mayor's proposal, which is then reviewed by City Mngr w/ inputs from Council, then back to Mayor for final discussion & vote.
 - Illegal fireworks? Parks maintenance & repair? Animal services (feral cats; pets of the homeless?) Additional suggestions?
 - * Support more MCAT (Mobile Crisis Assessment Team, to help w/ mentally-challenged situations)
 - * After-school programs for latchkey kids. [Input from D6 & others folded into <u>letter</u>⁶ sent by SJADLG to Mayor & Council, 2/12/24]
- Advocacy and Community Group updates; other new topics
 - Save Our Trails -- LLA for Bill Rankin: join us 5/5/24 for a 12-mile bike tour of part of City Loop Trail.
 - SJ Park Advocates -- Jean Dresden
